

The return of the hunter!

The temperatures on Gigha might be dropping, but some of autumn's distinctive night sky sights are starting to rise higher above the horizon providing a good reason to wrap up and spend a little time under the stars this November.

Orion is probably the most recognisable of all the constellations, rising in the east around 10pm this month. Named after a hunter in Greek mythology, the bright stars Bellatrix and red super-giant Betelgeuse form the shoulders of the figure in the night sky.

At 10 million years old, Betelgeuse is a relative youngster compared to our 4.5 billion-year-old Sun, and yet it has already burned through much of the fuel at its core. Once the fuel is gone, Betelgeuse will reach the end of its life in an enormous explosion called a supernova. One of the most distinctive parts of Orion is the three-star belt and bright sword. While the sword looks like it is made up of stars, if you have binoculars you may be able to make out that the sword is actually a more fuzzy patch of light. This is an enormous nebula, a large cloud of gas in which scientists have witnessed new stars and planets being formed.



Dark Skies Gigha

Prepare for blast off!

Dark Skies Gigha's plans to promote the Isle of Gigha's exceptionally dark night skies received some good news last month. The National Lottery Awards for All Scotland awarded the group £3500. This will be used to create a 'Dark Sky Theatre' at the far north of the island which is well away from light pollution. The 'theatre' will feature a night sky interpretation board, benches and stargazing pamphlets to help islanders and visitors find their way around the constellations in Gigha's beautiful dark night sky.

The group were also delighted to receive £840 from the Isle of Gigha Heritage Trust's Community Fund. This sum will be used to purchase multiple sets of astronomical binoculars for community use at stargazing events.

Dark Skies Gigha is a non-profit community group which aims to encourage and facilitate an interest in observing the night sky as well as providing educational experiences through regular events covering all age groups. The group also raises awareness of the detrimental effects of light pollution on wildlife, humans and the night sky. Dark Skies Gigha is a fully constituted group and is run by a committee of five Gigha islanders.

Countryside Ranger

Autumn is upon us and its all about the warm glow of nature. The whole island has turned a shade of copper as the bracken starts to wilt and die off, the trees are presenting their autumnal orange displays, and the fly agaric fungi have made a spectacular appearance at the north end of the island. The island is also seeing its influx of winter visitors. Greylag geese have started coming in their hoards, northern divers are now dotted around the coastline and red-breasted mergansers are becoming bolder splashing around in the shallows.



As part of the Marine Litter Working Group that the ranger service is involved with, training opportunities are being provided for community members to collect data to make a difference to the state of the beaches around the island and national policies for marine plastics in the future. The Marine Conservation Society are offering training for Gigha to become part of the Marine Conservation Society's (MCS) official beach surveys.

The data collected from the surveys are used to inform government decisions and help to shape policies (for example of the ban of plastic cutlery). The training will be offered online and cover how to complete their surveys, how to store the data, and how to become more involved with wider marine litter initiatives. On to another form of pollution, some may have noticed the noise pollution around Achamore Gardens in the last week or so. This was a result of a chainsaw course being undertaken by members of the community, partly funded by the Gateway to Gigha Project to enable community members and young people to upskill and receive training for skills to be maintained on the island. The group did an amazing job of thinning some of the shelter belts around the Gardens and improve site safety by clearing dangerous trees near to the pathways. We hope to run a second round of chainsaw courses in the new year to allow more people to take part and improve the skills they learned this week!

This autumn will also see the start of new monthly "forest school" style sessions initiated by Hannah Storie, and run by both Hannah and Casey-Jo. Our first session will be held on Saturday 6th November at 13:30, and be in-keeping and be in-keeping with the spooky time of year by focusing on the bat species found on Gigha, as well as some woodland

cooking, crafts, and wood work. This session is open to children of all ages, but we do ask that you book a place with us as spaces are limited for this session. You can contact Casey-Jo on ranger@gigha.org.uk, or speak to Hannah at the shop. We hope to see you there!

E33 Enercon “Harmony” Turbine

The E33 Enercon turbine is unfortunately out of action again and Enercon technicians have been over a couple of times now trying to resolve the new faults and are now awaiting parts again.

The pole shoes from the previous fault are still on order and we have been told that some sites have now had these parts fitted so hopefully there should be some coming to us shortly, but still no delivery date

The insurers are waiting for further information from Enercon so as to assist with our claim for loss of production.

We have been chasing Enercon up, but manufacturers in China are still catching up with all the back orders due to the Covid pandemic.

Homehunt Gigha

If you wish to apply for Trust housing you must firstly be registered with Homehunt Gigha, even if you are already a Trust tenant. Your registration date could be relevant when properties are allocated as they are allocated using the following criteria:

1. Best Use – do you fit the best use of the property compared to another applicant? i.e. using all available bedrooms.
2. Priority Pass Level awarded – the applicant with the highest level pass (gold, silver or bronze). You may apply for a Priority Pass under 4 different categories.
3. Date of registration – if the first two criteria are equal, the applicant registered first would be allocated the property.

Net Zero Gigha Group

In last month's newsletter we put a call out for anyone looking to join a community group that will look at ways to tackle climate change at a local level. The group held their first meeting where many proposals and ideas were shared. The group hope to host a community open day in the new year – so keep an eye out for details!

In the run up to COP26, architects throughout Scotland are aiming to raise awareness about the impacts of the Climate Emergency, particularly the potential impacts of local sea and water level rises and engage communities in what they might do to prevent a worst-case scenario. The architects have designed a travelling marker that is being moved around the country and have been in contact about Gigha hosting the marker from Monday 8th November - Monday 15th November. The marker is likely to be placed near the Activity Centre to allow for easy access and visibility. Keep your eyes peeled for posters at the noticeboard and on Facebook for more details!

Welcome Hut

Adjacent to the Activity Centre, you may have seen some clearance works for our new Welcome Hut which is being made by Auchencorvie sawmill. The 8ft wide wooden hut will host visitor management signage and a place for leaflets to be held to ensure visitors are accessing as much information as possible before exploring Gigha. The hut is due to be delivered soon and the area cleared will also host one of the stone interpretation points as part of the Gateway to Gigha project.

It's been another busy month of the Gateway to Gigha Project. With delivery of all aggregate and stone, and onward transit to path build sites, construction of the network is well underway. Elsewhere, a site visit has been held for contractors interested in tendering for work on the Phase 2 or 'trod path' routes.
